# Grants of up to \$30,000

for Businesses Started during the Pandemic

On November 16th, Governor JB Pritzker and the Illinois Department of Commerce and Economic Opportunity (DCEO) announced another round of Back to Business relief grant funding. The B2B NewBiz Grant Program will provide a total of \$25 million in grants to businesses having opened during the height of the pandemic, 2020-2021.

The Back to Business New Business Grant (B2B New Biz) Program, administered by the Illinois Department of Commerce and Economic Opportunity (DCEO), targets businesses which opened during the height of the pandemic, 2020-2021 to support their recovery from adverse economic impacts.

Grant funding may be used to help offset operational losses, bring back staff, and cover a number of eligible costs associated with maintaining productive business operations.

Applications for funding will be accepted between November 30, 2023 and January 11, 2024.
