It is with great pleasure that I present you with the annual report of the Veterans Assistance Commission of Kane County, Illinois, pursuant to Chapter 330, Part 45, Section 8 of the Illinois Compiled Statutes.

As the foremost veteran advocacy agency in Illinois' 7th most veteran populous county, we provide services in the following categories:

- 1.) Advocacy
- 2.) Benefit Application Filing and Claims Management
- 3.) Financial Assistance for Indigent Veterans

In Fiscal Year 2018, the Commission was instrumental in securing \$4,572,117.15 in new benefits for Kane County veterans, their dependents, and their survivors from the United States Department of Veterans Affairs (VA). That represents a return to the community of \$15.01 for every dollar of property tax revenue received by the Commission. That amount does not take into account money that we helped our veterans save by assisting them in accessing VA health care, home loan, or education benefits. Consequently, the Commission continues to be a significant and judicious governmental entity at the county level.

Glossary of Terms

Compensation: See "Disability Compensation"

Dependency and Indemnity Compensation (DIC): A tax-free monetary benefit paid to eligible survivors of military service members who died in the line of duty or eligible survivors of veterans whose death resulted from a service-related injury or disease.

Disability Compensation: A tax-free monetary benefit paid to veterans with disabilities that are the result of a disease or injury incurred in or aggravated during active military service.

Functional Zero: A goal that is reached when the number of veterans experiencing homelessness within a community is less than the average number of veterans being connected with permanent housing each month.

Intent-to-File: An application for veterans and survivors who intend to file a claim for VA compensation, pension, or survivors' benefits which preserves the effective date of future benefits while the claimant is gathering supporting documentation for their formal claim.

Non-Service Connected Pension: See "Pension"

Pension: A tax-free needs-based monetary benefit paid to wartime veterans, who meet certain age or non-service connected disability requirements.

Pension Management Center: A department at certain VA Regional Offices that is responsible for processing and adjudicating claims for pension, survivor's pension, dependency and indemnity compensation, and burial benefits.

Regional Office: One of 56 VA offices located nationwide responsible for processing and adjudicating VA benefits which primarily includes disability compensation.

Superintendent: Supervisor who has the executive powers of the Veterans Assistance Commission.

Survivor's Pension: A tax-free needs-based monetary benefit payable to a low-income, unremarried surviving spouse and/or unmarried child(ren) of a deceased wartime veteran.

VA Health Care: A comprehensive medical benefits package available to qualifying veterans which includes primary and specialty care at VA hospitals and clinics.

Veterans Service Officer: An individual who is accredited by the U.S. Department of Veterans Affairs and is able to assist veterans and their dependents in filing claims for benefits with the VA.

Work/Study Student: A veteran student who is using VA education benefits and is paid by the VA to do VA related work at no cost to the County.





Organizational Chart




Work/Study Interns (Seasonal, Up to Five at a Time)




Work/Study students are a wonderful asset to our team. They come at no cost through VA education benefit programs and worked a total of 1,684 hours in our office in FY 2018.


Section I: Operational Summary




Commission staff completed 90 more claims than in Fiscal Year 2017 representing a 13.3% increase in application filing workload. Filing applications for VA benefits remains the Commission's focus in its mission to maximize benefits for Kane County veterans. Our goal going into Fiscal Year 2019 is to leverage efficiencies to add elasticity to our current workload capacities. Commission staff will emphasize filing Fully Developed Claims, Decision Ready Claims, and utilizing the Stakeholder Enterprise Portal which will allow us to continue to grow our workload in future years and reduce the amount of rework performed by staff.




As a byproduct of an increase in the number of claims filed in Fiscal Year 2018, Commission staff completed 163 more forms than the previous fiscal year representing a 6.6% increase over last fiscal year. The number of forms completed is a solid production measure as claims filed can be relatively easy with filing one form or fairly complex with filing six or more forms in support of a single claim.




Commission staff prides themselves in identifying efficiencies in the claims filing process. Through continuous process improvement and quality control, Commission staff identifies submission techniques which, in addition to ensuring claim forms are thoroughly completed and error-free, promotes a faster average processing time. This is reflected in the chart above which shows that for the entire fiscal year, claims filed by Commission staff were processed faster than the average claim filed by an Illinois veteran. This is a testament to our staff's ability to adapt to change and also to the training they receive annually to maintain their accreditation. [1]




As depicted in this chart, a vast majority of the claimants that we file applications for receive a favorable decision on their claim. It should be noted that for the purposes of this chart "approved" means that at least one contention on the claim was approved, "denied" means that all contentions on the claim were denied, and "continued" means that the veteran was previously receiving a benefit but that our application did not cause an increase in that benefit.




This chart simply shows the amount of new benefits awarded to our claimants by the VA by fiscal year. Our new benefit payments production has increased by 118% since 2012.



The above chart shows that for the past two fiscal years, claimants who filed their claim through our office received a higher monthly benefit than the average claimant nationally. *Fiscal Year 2018 data is not yet available from the VA. [2]






The Commission's Financial Assistance Program for indigent veterans remains a small, but critical, piece of the Commission's mission. The program's utilization has declined due to Commission staff helping claimants obtain better federal benefits and veterans in Kane County having a significantly higher median income than the average non-veteran citizen residing here does. However, it serves as a vital lifeline for those veterans who have fallen on hard times. This program can pay a veteran's rent, utilities, as well as food and personal needs up to a capped amount that is dependent upon their family size. No funds are paid directly to the veteran with exception of food and personal needs vouchers which are given to recipients and are redeemable at Aldi's – a widely available grocery store in Kane County, which is also headquartered in Kane County, and provides the vouchers which are not redeemable for alcoholic beverages. The chart above shows the breakdown in utilization by service provided for our financial assistance recipients.




The veteran population in the United States is projected to decline by 38.8% by 2045. [3]




The interagency Kane County Homeless Veterans Task Force is actively engaging the homeless veteran population to reduce its number and reach "Functional Zero." [4]

Conclusion

Fiscal Year 2018 was a dynamic year for the Veterans Assistance Commission. With four fulltime accredited Veteran Service Officers, our performance metrics continue to improve over previous years. Staff continues to learn new processes as they become available through the VA, such as Decision Ready Claims, and then leverage those processes to improve claim efficiency and effectiveness for our clients. This year saw the start of the 16th Judicial Circuit's Veterans Treatment Court of which the Commission is a team member. We hope that our continued work with the Court helps those defendants succeed in their goals as we look for ways to quantify our investment there. The Commission has also been fortunate to have a dedicated pool of student veterans who work in our office through the VA's Work/Study program. The program allows veterans, who are enrolled as an at least \(^3\)4 time student through a VA education benefit program, to work at a veteran-centric agency for an average of 25 hours per week during the semester. This no-cost help for the Commission allows our Veteran Service Officers to emphasize their time on claims and applications they are filing for our clients so they do not have to worry about answering the phone or triaging walk-in clients. This has had a huge impact on staff's ability to maximize the number of claims filed, while still ensuring excellent quality of those claims, and delivering that exceptional service for a very affordable price for the property taxpayers of the County of Kane. We will strive to deliver another record year of services in Fiscal Year 2019 and we look forward to expanding new missions such as the Veterans Treatment Court. This resolution amends Kane County elected Board Members health and dental contributions to agree to the County Personnel Policy Handbook.

RESOLUTION NO.

AMENDING COUNTY BOARD MEMBERS BENEFITS

WHEREAS, Kane County is concerned about the rising costs of County expenses and healthcare costs; and

WHEREAS, the Kane County Personnel Policy Handbook, Insurance Benefits (page 40) states: "All regular full-time and regular part-time employees who work a minimum of 21 hours per week are eligible to enroll in the County's comprehensive group medical, dental, vision, life and supplemental insurance" (with the County contributing towards their insurance); and

WHEREAS, Employees who regularly work 30 or more hours per week as determined by a measurement period analysis will pay the employee contribution rate as full-time employees with the County contributing towards their insurance coverage; and

WHEREAS, Part-time employees who regularly work less than 30 hours per week as determined by a measurement period analysis will pay the full premium contribution rate for all plans for coverage with the County making no contribution towards their insurance coverage; and

WHEREAS, Board Members are eligible for insurance on the day they are sworn into office per Blue Cross/Blue Shield Business Program Application (BPA); and

WHEREAS, Kane County Board Members are currently receiving health and dental benefits at the full-time employee contribution rate; and

WHEREAS, Board Members do not meet the Kane County Personnel Policy Handbook requirements of the full-time employees but have been treated as full-time employees with the County contributing towards their insurance coverage.

NOW, THEREFORE, BE IT RESOLVED by the Kane County Board that the Kane County Board Members will no longer be considered full time employees for purposes of insurance benefits, but will be considered part-time employees in accordance with the Kane County Personnel Policy Handbook, wherein Kane County shall make no contribution toeards Kane County Board members' health and dental insurance coverage.
