BRIEF PROJECT DESCRIPTION

Complete demolition of structure and attachments on the property, recycling and disposal of the existing Kane County Sheriff's Adult Correction Facility's building, Post 8, and Sheriff's Office. The Contractor shall provide all necessary labor, machinery, tools, apparatus, equipment, and do all of the work necessary for the complete removal of the building, including all waste, rubbish and debris from the demolition per specification, from Kane County premises.

Complete removal of building foundation, supporting walls, concrete walls and footing, sidewalk, pavement, curb, tree, pipes, wiring, tanks, etc., and the filling of all voids occasioned thereby with satisfactory solid materials consisting of stone, gravel, and sand, free from debris.

Disconnection of any utilities presently connected to the building, including telephone, cable television, electric, natural gas, water and sewage, as directed by the Kane County and City Engineer.
