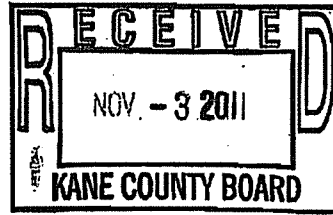

The new contract is commencing on December 1, 2011 and expiring on November 30, 2012.

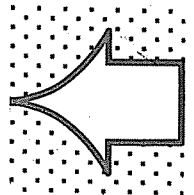


