The Cooperative Agreement, made the 24th day of June 2009 and entered into by and between the United States of America, acting by and through the United States Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS) on behalf of the Commodity Credit Corporation (CCC), and Kane County, Illinois (Kane County) for the implementation of the Farm and Ranch Lands Protection Program (FRPP) is hereby modified as follows:

IV. OBLIGATION OF FUNDS table is modified to change the 2009 closing deadline to October 17, 2012, and the 2009 payment request deadline to October 19, 2012, and the 2009 Fund Disbursement deadline to October 31, 2012.

XI. RESPONSIBILITIES A5. Is modified to read "NRCS shall certify payment... by October 31, 2012".
