RE: **FRAUD NOTICE TO VENDORS**

Dear Vendors:

Kane County staff was recently notified that fraudulent purchase orders have been issued in the Name of Kane County Purchasing with deliveries to warehouse facilities in Elgin and Bolingbrook, IL that are not Kane County buildings. Please be advised that these are fraudulent purchase orders issued in the name of the former Purchasing Director Christopher Rossman, with forwarded phone numbers and the email address [purchasing@kanecountyboard.org](mailto:purchasing@kanecountyboard.org). These fraudulent purchase orders contain third-party shipping addresses with the intent to bill Kane County for the stolen computer shipments scheduled to be sent to the United Kingdom. This matter has been turned over to the Kane County Sheriff's Office.

Please be advised that there are only two authorized shipping addresses for Kane County computer supplies and equipment purchases:

- the main government center at 719 S. Batavia Ave address in Geneva, IL
- the Sheriff's Office at 37W755 IL Route 38 in St. Charles, IL

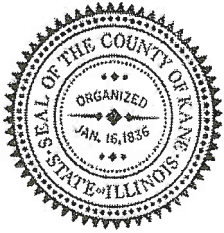
