



The 2019 Elevator Modernization project for Building C and the Health Department Building in Aurora was put out to Bid on March 19, 2019. Over seven contractors were notified of the project and seven of them obtained bidding documents and attended the mandatory pre-bid meeting. At the bid opening date of April 30, 2019 we received 2 bids which were opened publicly for the aforementioned project.

The attached Bid Tabulation document illustrates the recorded bid and the plan holders. There were two alternates that were bid for the project to complete interior elevator cab improvements for the two elevators, one alternate per site (Alternates #1 & #2). The project budget estimate including a 10% contingency was \$239,000 plus \$14,000 per elevator for the Alternate #1 & #2 for Cab improvements for a grand total Project Budget estimated at \$267,000. The lowest responsive and responsible bidder for the project was Urban Elevator Service for a total base bid of \$218,559.00 plus \$13,500.00 for Alternate #1 and \$13,500.00 for Alternate #2 plus they offered a Voluntary Alternate to install new stainless steel skins on the inside and outside elevator cab doors and transoms for a total cost of \$10,000 which brings the grand total Bid value with the accepted alternates #1 & #2 and Voluntary Alternates to \$255,559. This Bid value, plus the recommended alternates is \$11,441 below the estimated cost.

We proceeded to do a project scope review with Urban Elevator Service after the Bid Opening to ensure that they fully understood the project and the contract requirements. They acknowledged full understanding and acceptance of the terms and conditions. We also reviewed their qualification statement and references and are satisfied that they meet our recommended standards. As such, it is our recommendation that Urban Elevator Service be awarded the Contract for the bid total of \$255,559.00 in accordance with the bidding documents for the aforementioned project. We also recommend that a Project Contingency be set aside for the project for approximately 8% of the Contract Value. The recommended contingency value for the project is \$20,445.



I'm contacting you concerning the Cornerstone landscaping contract for the FY2019 season.

Building Management has recently met with Theresa Dobersztyn, Kane County Purchasing Director concerning the Mill Creek/Cornerstone landscape maintenance contract extension. Review of both state & county procurement policies has brought to our attention that a "best practice" policy should have us combine the landscape maintenance agreement along with the variety of other smaller grounds maintenance contracts that Mill Creek currently has with Cornerstone into one "umbrella" contract.

In the interest of time, Purchasing has advised that we can submit for Kane County board approval, the second of three available contract extensions which will stipulate that all current contracts with Cornerstone will be combined into one inclusive agreement. However, prior to submitting a resolution to this effect, we need to know that Cornerstone would be amenable to this.

The following individual contracts would be submitted as one Mill Creek grounds maintenance contractual agreement to the Board this March:

- Landscaping Maintenance
- Spring/Summer Floral/Plant Enhancements
- Fall Flowers/Plants
- Tree Watering Services
- Off Season Trash Receptacle Maintenance
- Off Season Trash Policing
- FY2018 Miscellaneous Projects
- Potential Extra Clean-Up/Mow

There may have been a few minor ones not included in this list, but those would easily fall in a "miscellaneous" projects category, as random grounds maintenance issues come up over the course of a season. That said, the categories listed above came to a total of well over \$132,000.00.

This umbrella contract would assure that the Mill Creek SSA is trying to adhere to procurement policies for the present fiscal year. The thought is that for FY2020, the SSA will go out for bid and not exercise the third year optional extension on Cornerstone's existing contract. Please keep in mind, that while we feel Cornerstone has provided excellent service over the course of the last several years, we need to ensure that Mill Creek is moving forward in making sure procurement policies are being followed as prescribed.
