Dear Requester,

We are in receipt of your request under the Illinois Freedom of Information Act ("Act. Attached is a copy of your request. Please be advised that certain information has been redacted, or deleted, from these records pursuant to the following exemption:

**Exemptions - Private Information**

Section 7(1)(b) of FOIA exempts from disclosure "private information, unless disclosure is required by another provision of this Act, a State or federal law or a court order." Under section 2(c-5), "private information" includes:

[u]nique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person.

**Exemptions - Personal Information**

Section 7(1)(c) of FOIA exempts from disclosure personal information contained in public records if disclosing that information would constitute a clearly unwarranted invasion of personal privacy for the person or persons to whom the information pertains. "Personal information" has been defined by the courts as information "that is private and confidential." *Chicago Tribune v. Board of Education of the City of Chicago*, 332 Ill. App. 3d 60 (1st Dist. 2002). For purposes of subsection 7(1) (c), an unwarranted invasion of personal privacy means "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information.

Since redacting the information specified above constitutes a partial denial of your FOIA request, please be advised that you may seek review of this partial denial either by judicial review pursuant to Section 11 of the Act, or by submitting a request for review to the Public Access Counselor in the Office of the Attorney General at the address set forth below. Any request for review to the Public Access Counselor must be in writing, signed by you, must include a copy of your request and the response, or responses, you have received from the City, and must be filed not later than sixty days after the date of this partial denial.

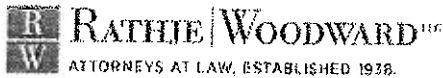

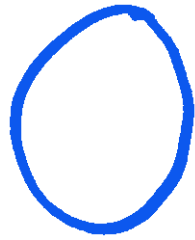
